Definition of terms:

FunPark: is a place in which a space is reserved for skiing and snowboarding lessons for the needs of SKI School Ještěd and space for sledding, bobsledding and snow tubing. It can also be used by the paying public.

1. FunPark opening hours:

1. Operating hours are daily from 8.30 a.m. to 4 p.m.
2. In case of high demand, it is possible to extend the operating hours until 21.00.

2. Age of children

1. FunPark is open to all visitors of any age.

3. Child's entry to the FunPark

1. Entrance to the FunPark is possible only through the turnstile or accompanied by a ski school instructor JEŠTĚD SKI SCHOOL or independently, after paying the entrance fee. Visitors younger than 18 years of age must be supervised by a legal guardian.
2. Accompaniment for children under 18 is free of charge.
3. The capacity of the FunPark is 50 children. This capacity can be increased, but TMR Ještěd a.s., reserves the right not to accept additional children beyond this number for safety reasons.
4. TMR Ještěd a.s., also reserves the right in case of high interest in the JEŠTĚD SKI SCHOOL not to allow the client to enter the FunPark without an instructor.
5. TMR Ještěd a.s., in the interest of all visitors to the FunPark, reserves the right not to accept children with infectious diseases, including rhinitis, cough, diarrhea and other symptoms of illness. Allergies or other permanent illnesses and medical conditions must be reported in the child's interest at the time of the child's admission. If the playgroup

staff have information about health problems, they may treat children individually. Based on the records, it is possible to trace the possible beginning of an infection or epidemic. This information can be provided on request only to the health service.

6. Persons (children and their accompanying persons) who show clinical signs of covid-19 disease shall be prohibited from using the services of the operator.
7. Access to the part of the FunPark reserved for ski lessons is not permitted without a ski or snowboard equipment, the child's companion will not be allowed entry unless he/she has this equipment, walking in this reserved area without skis on their feet is not allowed.

4. Return of the child

1. The child will be handed back after the lesson at the ski school JEŠTĚD SKI SCHOOL. In case the child will be picked up by another person, it is necessary to report this person already when picking up the child. The person picking up the child must not be under 18 years of age.

5. Storage of the child's personal belongings

1. Children will be able to put their clothes, sports equipment and personal belongings in a designated place - the office of the ski school JEŠTĚD SKI SCHOOL. TMR Ještěd a.s. is not responsible for items left outside the designated area. TMR Ještěd a.s. is also not responsible for any damage or loss of valuables brought in. It is therefore recommended not to give valuables to children at all during the child's time in the FunPark.

6. Rules of conduct in the FunPark

1. It is forbidden to sledge, bobsled or move around without skiing/snowboarding equipment in the FunPark area intended for skiing and snowboarding lessons.
2. In the area of the FunPark reserved for bobsleighbing/snowboarding, skiing and snowboarding is prohibited.
3. Do not enter the area designated for SNOW TUBING.
4. The SNOW TUBING track may only be used by one user/rider at a time.
5. Visitors are always obliged to follow the instructions of the FunPark staff (instructors, lifters).
6. It is not allowed to bring any sharp objects and pets, smoke or drink alcohol into the FunPark.
7. If the children/visitors behave in violation of the rules of operation or if they do not follow the instructions of FunPark staff, the staff will inform the child's companion to pick up the child immediately. Such children will no longer be allowed entry. The operator will do this especially if the child causes conflicts or has inappropriate or even aggressive behaviour. It may be that the child needs a person to bring the child to the FunPark earlier than the time agreed when the child was admitted for any reason. The person responsible for the child must be in a location not too far away from the child, have their mobile phone on or otherwise ensure their availability while the child is in the FunPark.
8. Photography for professional purposes or for the press by third parties other than TMR Ještěd a.s. employees is not permitted.
9. The escort will wear a respirator if the anti-epidemiological regulations at the time of use of the FunPark require the wearing of respirators, FunPark staff are entitled to control the wearing of respirators.

7. FunPark staff and safety

1. Children are looked after by staff who have the necessary pedagogical or medical education, are properly trained and have relevant experience in working with children (Ještěd Ski School instructors).

2. The JEŠTĚD SKI SCHOOL office is equipped with a first aid kit. In case of any injury, the staff will provide basic treatment or first aid, or call the mountain or rescue service.

8. Lift and mobile tracks

1. The transport conditions for lifts and mobile tracks in the FunPark are subject to the general transport conditions set out in the Transport Regulations and the Contractual Transport Conditions.
